### EVV News

EVV, or Electronic Visit Verification, is a web-based system that verifies when provider visits occur and documents the precise time services begin and end. It ensures that people receive their authorized services. This new technology is now required by federal law for certain services provided through NJ FamilyCare/HCBS.

The Division of Medical Assistance and Health Services (DMAHS) intends to implement an EVV system that meets state and federal requirements with broad public support and a strong and enthusiastic stakeholder process.


The Center for Health Care Strategies along with DMAHS is co-facilitating the EVV Steering Committee and the three workgroups; Provider, Family & Members and Self Direction. The EVV Steering Committee meets monthly to review progress, obtain feedback, and make decisions as needed. The charge of the three workgroups is to identify issues, suggest solutions, and report back to the Steering Committee. Currently, the groups are in the process of updating the EVV FAQs (on DMAHS website), refining a communications plan, considering a potential hotline, as well as DMAHS being available for updates and discussion during DDD Webinars. DMAHS is in the process of clarifying the process with federal guidance.

Values Into Action's Family Mentor/SHIP Counselor, Zinke McGeady, is an involved participant on two workgroups and the EVV Steering Committee.

### **A Letter from Jonathan Seifried on Day Program Closures**

Hello Division Constituents and Community Partners,

As you may know, positivity rates and community spread of COVID-19 in New Jersey have increased in recent weeks. To reduce exposure risk for the individuals we serve, and their families and caregivers, the Department of Human Services' Division of Developmental Disabilities has made the difficult decision to close all Division-funded in-person congregate day service facilities for a second time.

**All Division-funded in-person congregate day service facilities are directed to close again effective close of business November 25, 2020 through at least January 19, 2021.**

### **Mounting Evidence Points To Serious COVID-19 Risk For Those With IDD**

People with developmental disabilities who contract COVID-19 face a higher risk of dying from the virus than just about anyone else, new research indicates.

A review of private health insurance claims data for 467,773 people diagnosed with the coronavirus in the U.S. between April and August finds that individuals with developmental disorders are three times more likely to die compared to others. That's the highest risk of any of the 15 conditions that the study looked at, which included heart failure, chronic kidney disease, liver disease and various types of cancer.

### **Update: 2021 Cost-of-Living Adjustment**

To help people who receive benefits and payments keep up with the changing cost of living, Social Security beneficiaries often receive an annual cost-of-living adjustment (COLA). Each year Social Security bases the COLA on changes in the Consumer Price Index.

**For 2021, Social Security benefits and Supplemental Security Income (SSI) payments will increase by 1.3%.** This means that more than 70 million Americans will see a change in their benefit payments.
