District-Wide Educational Goals

In acknowledgement of the unique and challenging academic, therapeutic, social and emotional needs of our students, the Bergen County Special Services School District continues to commit all of its resources to help every pupil in the District to:

- 1. To acquire basic skills in obtaining information, solving problems, thinking critically and communicating effectively;
- 2. To acquire a stock of basic information concerning the principles of the physical, biological and social sciences, the historical record of human achievement and failures, and current social issues;
- 3. To become an effective and responsible contributor to decision-making processes of the political and other institutions of the community, State, country and world;
- 4. To acquire the knowledge, skills and understanding that permit him or her to play a satisfying and responsible role as both producer and consumer;
- 5. To acquire job entry level skills and also to acquire knowledge necessary for further education:
- 6. To acquire the understanding of and the ability to form responsible relations with a wide range of other people including, but not limited to, those with social and cultural characteristics different from his or her own;
- 7. To acquire the capacities for playing satisfying and responsible roles in family life;
- 8. To acquire the knowledge, habits and attitudes that promote personal and public health, both physical and mental;
- 9. To acquire the ability and the desire to express himself or herself creatively in one or more of the arts and to appreciate the aesthetic expressions, of other people;
- 10. To acquire an understanding of ethical principles and values and the ability to apply them to his or her own life;
- 11. To develop an understanding of his or her own worth, abilities, potentialities and limitations;
- 12. To learn to enjoy the process of learning and to acquire the skills necessary for a lifetime of continuous learning and adaptation to change.

- OBJECTIVE #3 100% of students who have Science objectives in their Individualized Education Programs (IEPs) will follow NJCCCS and demonstrate mastery of 80% of those objectives with the assistance of technology.
- OBJECTIVE #4 100% of students who have Social Studies objectives in their Individualized Education Programs (IEPs) will follow NJCCCS and demonstrate mastery of 80% of those objectives with the assistance of technology.
- OBJECTIVE #5 100% of the students will follow the Ling and/or program curriculum for articulation, syntax, semantics, pragmatics and communication competencies as presented in their Individualized Education Programs (IEPs) and demonstrate mastery of 85% of those objectives.

Program 3 — Behavioral Disabilities (School Code 050)

- OBJECTIVE #1 80% of students will increase their reading and writing levels using structured reading programs, as measured by pre and post assessments, report cards, and data collection.
- OBJECTIVE #2 90% of students will participate in social skill development programs and techniques and increase use of appropriate social skills development, as measured by a decrease in incident reports, pre and post assessments, student feedback and analysis of behavioral intervention plans.
- OBJECTIVE #3 75% of junior and senior students will participate in community based internships with local businesses and adult support agencies and increase work related skills as evidenced on employer/mentor evaluations, situational assessments, structured learning experience plan, job coach reports, and registration with NJ DVRS.
- OBJECTIVE #4 The average daily attendance rate for students in these schools will result in a three year average of not less than 90%.
- OBJECTIVE #5 80% of students will increase knowledge of and apply self advocacy skills by active participation at IEP meetings, input in IEP goal development, requests for instructional modifications and learning strategies based on learning styles.
