* <u>DISTRICT HIGHLIGHTS, ACCOLADES AND OTHER IMPORTANT DISTRICT INFORMATION</u>

Dr. Lerner shared some highlights of the many accomplishments our students and staff have had, including the following:

NAVIGATING SUCCESS THROUGH WELLNESS INITIATIVE

- Restorative Groups (post-HIB) in progress so students may understand and process what has occurred and a learning component will eliminate this from happening again.
- Mental Health Wellness workshop series, specific to staff, students, and parents are ongoing and continue to be well received and beneficial.
- Wellness Ambassador Program launched at all the campus.

Institute for Interactive Design @ Northern Valley – Demarest & Old Tappan

• 10th grade students had classes in December that incorporated Virtual Reality activities using the equipment in the "VR Studio" at both Demarest and Old Tappan.

APPLIED TECHNOLOGY HIGH SCHOOL

• From December 1, 2021 thru January 14, 2022, the ATHS school Climate Team organized a food drive and fundraiser for the Community Food Bank of New Jersey. As a school community, we collected dozens of boxes filled with food and we raised approximately \$900, which provides about 2,700 meals for those in need.

Bergen County Academies

- Seven BCA Students have been named National Semifinalists in the **2022 Regeneron** Science Talent Search. BCA has the highest number of semifinalists in New Jersey and the third highest number of semifinalists in the Nation.
- Seventy students have qualified for the **NJ DECA State Conference**. Twenty-six students placed in the Top 3 regionally and BCA swept 1st, 2nd, and 3rd place in the Business/Finance event.

PARAMUS CAMPUS

The BCTS Paramus English Department organized a school wide "Gallery Walk." Students
were tasked with analyzing quotes and character traits relating to the Hindu Literature
"Numskull and the Rabbit." Their collaborative efforts were highlighted in a visual display to
all students at the school.

TETERBORO CAMPUS

- Sea Souls was a short film created in two weeks by three Bergen Tech students. Sea Souls is about a lonely little ghost who is visited by a mysterious diver. The students won an Honorable Mention at the NYC Teen Film Festival.
- A Bergen Tech 12th grader has started the first chapter of its kind in a high school of the Farmlink project. The chapter has helped move more than 1.2 million pounds of surplus food from farms to food banks in communities in need.

ADULT EDUCATION

- The Career Services section of the Adult Ed website is now complete. It is an effective platform for communicating with local contractors regarding employment needs.
- New classes will enter plumbing now, and Electrical in March. With the new groups, both programs remain at full capacity.

❖ Dr. Lerner Shared The Progress Report On The Goals That He Set At The Start Of The Year:

- Resiliency Training: Resiliency Trainings for 9th grade students have been completed at BCA, ATHS and Paramus. Teterboro will begin their training now and complete it by April 2022.
- Aspiring Leaders: This action plan began with a communication going out to all certificated staff this fall to inform them of the opportunity to learn more about different leadership roles in our district. An application was developed and 20 district teachers applied to part of this cohort. The first part of this seven-session program will begin in mid-January and will include such topics as: maintaining a safe school, building a positive workplace culture, and fostering a

diverse and inclusive environment. The Aspiring Leaders program is scheduled to wrap-up by the end of April and will include a post-survey for all participants.

Alumni Survey: In collaboration with our central administration and building principals, and after careful review of archived surveys as well as those from other LEA's, a new, online alumni survey was created this fall. Through the efforts of our school guidance departments, a survey link was sent out to alumni of all ages. By the end of December, we had 746 responses that ranged from the class of 1997 all the way up to the class of 2021. These results are now being compiled and readied to be integrated into our district and school planning process.
