* Recognition of 50 years of service to the community – Mike Tarantino, Bergen County EMS Director

Dr. Howard Lerner, Superintendent, made the following comments:

In October of 2021, our own Mike Tarantino, Director of the Bergen County EMS Training Center, was honored for over fifty years of service to the City of Rutherford. His extensive length of service started in 1971, when he joined the Rutherford Ambulance Youth Squad. This path led him to serve as a Youth Squad Training Officer, Youth Squad Lieutenant, Squad Second Lieutenant, Squad Training Officer, Squad Captain, Corporation Vice-President, Corporation President, and as Chairperson of multiple committees.

Mike has seen a multitude of changes and improvements in the EMS industry. Ambulances, which were once high-topped car bases (usually Cadillacs), have now evolved into the custom built, fully-equipped minihospitals that they are today. Mike has been a vital part of the evolution in training, which has become more comprehensive by providing instruction to trainees to acquire the knowledge and skills necessary to stabilize and safely transport patients, from the routine call to life-threatening emergencies where timing is critical. Additionally, trainings now require 220 hours, as opposed to the 50 required in 1970 when Mike first joined the Youth Ambulance Squad.

Even as Mike continues to oversee training at the Bergen County EMS Training Center, he has continued to selflessly give his time to the Rutherford Volunteer Ambulance Corps, (where he is now the Captain) and he also serves as the Coordinator of the Office of Emergency Management for Bergen County.

Congratulations on your great accomplishments Mike and your tremendous service to our county and beyond.
