BOARD SECRETARY/BUSINESS ADMINISTRATOR'S REPORT

Board Secretary John Susino provided the following report to the Board.

Budget Calendar for School Year 2023-2024

In the coming weeks, the administration will begin the budget process for the next school year. This process begins in late October/early November with the business office providing principals and program managers with historical data on their budget lines. Principals and managers are given approximately 1 month to review, develop and present their proposed budgets, wish list items, projected enrollment figures, and other recommendations to the district's Assistant Superintendent, Ms. Sheridan, and to the business office. In December, all recommendations and requests are presented in a draft budget to the superintendent. Dr. Lerner, along with his central administration staff, will work to draft a balanced budget that takes into account programmatic requests, fixed costs and revenues. I will present this draft budget to the board at its February meeting. The board will then have one month to review and comment on the budget with action to follow in March. At that time, the administration will submit the approved budget to the NJ Department of Education for its review and approval. Finally board members, we hope to present the approved budget to the board of school estimate in April of 2023.

Dr. Lerner shared highlights of the many accomplishments our students and staff, including the following:

NAVIGATING SUCCESS THROUGH WELLNESS INITIATIVE

- Completed in-person "Wellness Meet & Greets" and wellness assessments on students who
 missed summer screenings; all four campuses and in person screenings in both NV schools
 were facilitated:
- Social workers collaborated with CST and BCSS behaviorist to create effective student and
 family intervention and support to address a complex and challenging set of circumstances
 negatively impacting the student; parents and student were involved in a series of virtual
 meetings and were able to resolve the problem with support and guidance from NSTW staff.

APPLIED TECHNOLOGY HIGH SCHOOL

 Applied Technology celebrated Hispanic Heritage Month with a visit from a Bergen County based Latin dance company. Students and staff had an opportunity to watch professional demonstrations of Salsa, and Merengue, and the dance company also provided lessons following each performance.

BERGEN COUNTY ACADEMIES

- The Bergen County Academies kicked off the school year with a school convocation. The assembly opened with a video and dance performance, new teachers were introduced, the Student Council President spoke to the students and the new school theme "Stronger Together" was introduced. Finally, a year in review highlight video was shown. Both Students and staff indicated they enjoyed the event.
- Class of 2003 Alumni Justyn Davis returned to BCA to speak at the School Convocation Assembly and to present his Emmy award for a pre Super Bowl show. Justyn donated the award to the school in recognition of those who inspired him as well as to inspire future students to work hard. Justin chronicled his journey from learning video production at BCA, as well as filming the County Commissioners meetings, to his current work in cinematography. The Emmy for his work on will be on display in the BCA main lobby.

PARAMUS CAMPUS

 The BCTS Paramus Culinary students baked and donated over 300 cupcakes for the Walk for Women's Cancer event in support of the Lewin Fund. All cupcakes were topped with the Lewin Fund edible logo. This was part of the Paramus Campus ongoing CTE In-Service initiative presented at last month's meeting.

Teterboro Campus

- 3 Bergen Tech 11th graders were selected to serve on the Bergen County Junior Commission on the Status of Women. These students will spend the next year serving as a bridge between government and community, studying the needs of women and promoting the expansion of women's rights in areas such as domestic violence, child care, and elder care.
- A 12th grade Law & Justice student earned the National Speech & Debate Association's Academic All-American Award fewer than 1% of students earn this award every year!

Institute for Interactive Design @ Northern Valley – Demarest & Old Tappan

UX/UI Design

- Students watched and discussed a series of award-winning animated shorts touching on anti-bullying topics for Week of Respect
- o Old Tappan and Demarest held their first UX/UI club meetings of the year this week where club officers were nominated
- Old Tappan had an IIDT "Gaming" luncheon where students from all grade levels bonded over games and discussed the extracurriculars they have enjoyed so far with the wellness coordinator.

• Exercise Science/Sports Medicine

- Old Tappan and Demarest Sports Medicine students watched a clip of a specific injury and discussed the type of injury which led to a discussion of the legal and ethical issues within sports medicine.
- Old Tappan and Demarest Sports Medicine students utilized the classroom skeleton and then themselves to identify the bones of the body.

ADULT EDUCATION

- Our daytime trade programs are almost full for the classes starting in fall of 2022. There is
 even a waitlist for our electrical program and few spots left for our HVAC and Plumbing
 course.
- Adult Education and New Bridge Medical Center have teamed up to create internship and apprenticeship opportunities for our students and alumni within the plumbing and electrical fields.

- During the month we continued our training for the civilian side of the United Nations
- Our Rescue Instructors conducted a rappelling demonstration from the sixth floor of the new burn building at the Bergen County Law & public safety Institute.
